Subgroup Minimum Premium Endorsement

Provided that this **Policy** is part of the Euler Hermes World Program, agreed between Euler Hermes World Agency and (Name of Insured's HQ/Parent) as detailed in the Master Agreement n° (World Policy Number) dated (Date) of which you confirm that you have knowledge, you and we agree that:

1. For the purposes of this endorsement:
 - 1.1 “**Subgroup Policies**” means the **Policies** collectively designated as a specific group in the Policy List;
 - 1.2 “**Subgroup Premium**” means the total amount of premium (excluding any taxes) paid or payable under the relevant **Subgroup Policies**, for one Insurance Period, irrespective of the application of any minimum premium clause
 - 1.3 “**Subgroup Minimum Premium**” means the total amount of all Minimum Premiums applicable to the relevant **Subgroup Policies**
2. *If, following the declaration of **Turnover** made under the relevant **Subgroup Policies** for an Insurance Period, the **Subgroup Premium** for that period exceeds the **Subgroup Minimum Premium** for that same period as specified in the **Special Terms**, then the minimum premium referred to in Section 4.02 of the General Terms and Conditions of this **Policy** will not apply.*

3. *If, following the declaration of **Turnover** made under the relevant **Subgroup Policies** for an **Insurance Period**, the **Subgroup Premium** for that period is less than the **Subgroup Minimum Premium** for that same period as specified in the **Special Terms**, then the minimum premium referred to in Section 4.02 of the **General Terms and Conditions** of this **Policy** will apply until the **Subgroup Minimum Premium** has been attained. We, at our sole discretion, will determine the proportion of the contribution to the **Subgroup Minimum Premium** to be made under each of the **Subgroup Policies**. For that purpose we will only consider those **Subgroup Policies** under which the minimum premium applicable to that **Subgroup Policy** has not been attained.*

4. For the purposes of establishing if the **Subgroup Minimum Premium** has been reached, amounts relating to premium will be converted into the currency of the Master Agreement using the exchange rate specified in the **Special Terms** ruling at the date of our calculation of the **Subgroup Minimum Premium**.
